# Membership Meeting Thursday, November 8, 2012 Approved Minutes

President/Treasure: Mike Kahrs at 7:07 pm.

Welcome members, guests and speaker. The change made to the proposed agenda was to have the guest speakers go first.

**Special Speaker:** Mike at 7:12 pm.

Introduced the guest speakers, Doug Cox and Donghu Chang, City Traffic Engineers, Seattle Department of Transportation (SDOT) to address plans for establishing a Greenway through Central Ballard. The Ballard Greenway is a residential route with enhancements for people powered transportation including bikes, foot and scooters proposed to run west from 4th Avenue NW to Shilshole mostly along NW 58th Street at low speed of 20 MPH. There would be added signage, charrots, and speed bumps but no change to parking. The crossing at 24th NW would require major enhancements including traffic islands and other changes to the intersection. There were concerns expressed about intersection safety as well as interference with traffic. Questions were also raised about speeds of traffic at the intersection at 20th Avenue NW. Public input is encouraged.

- 3. Will partner to support and participate in the Ballard Chamber of Commerce's "Ballard Partnership for Smart Growth" Tier II grant proposal to promote leadership at \$50,000.
- 4. Sponsor SPD's/Mayor's 20-20 Phase II, "Safe Communities" meeting with representatives that live and work in Ballard from areas south of Crown Hill.
